1. The Engager engages the Leader to provide a combination of musicians appearing as

2. It is agreed that the inclusive fee for the engagement shall be payable in cash or by cheque on the date of the performance.

3. Performance in addition to that specified in Clause 1 above shall be subject to fees and conditions to be agreed between both parties. Please check mark appropriate items.

4. It is agreed by both parties to this contract that the Engager shall provide at no cost to the Leader or his crew a food or bar tab of \$ if initialled by the Engager here:

5. It is the responsibility of the Engager to take all reasonable steps by way of stipulation in booking providing the venue for the engagement, to ensure a safe supply of electricity and the security of their personnel, their equipment & property at the venue. **Canopy Tents** will be provided **Mule/Golf Carts/Driver** will be provided if initialled by the Engager here:

6. Set Up and Load Out: The Engager will provide the Artist and personnel with reasonable access to the venue before the performance to load in, set up, do sound checks and load out after the performance. The Engager will provide secure onsite parking for the Leader and personnel.

7. This Agreement may not be modified or cancelled except by mutual consent, in writing and signed by both parties.

8. CANCELLATION OF PERFORMANCE The performance may only be cancelled by written notice received by the other party, no less than 21 days before the performance date/s.

9. Deposit is not refundable in the event of cancellation, if any performance is cancelled without proper written notice within the cancellation period specified in item 8: The Leader may cancel at any time if unable to perform due to sickness, injury, transport problems, weather conditions or anything beyond their control, and is liable to repay any amounts paid by the Engager prior to the Leader cancelling. In the event this engagement is cancelled due to inclement weather, the Leader shall be paid in full or the amount of \$ (.....) (Engager Initial Here), provided the Leader is present to perform. Should the Leader fail to appear this contract is null and void
